#### How to get Disabled Students' Allowances (DSAs) in 3 easy steps

#### Tell us about your disability

To do that you will need to answer all the questions in sections 1-7 that apply to you, sign the declaration and return this form to us.

You will also need to send us evidence to confirm what your disability is. The sooner we receive your completed form and all evidence - the quicker your DSA support could be in place.

#### Find out exactly what equipment and support you need

If you are eligible for DSAs we will send you a letter and ask you to arrange a Needs Assessment.

After you attend your Needs Assessment you will receive a Needs Assessment Report, which identifies the equipment and other support you may need for your course. We will also receive a copy of this report.

This process can take some time – so make sure you book your Needs Assessment as soon as possible after you get our letter so that you can get all the necessary equipment and support before your course starts.

#### Get your equipment and support

Once we've received your Needs Assessment Report, we will send you another letter to tell you what equipment or other support can be paid for from DSAs.

We will also give you instructions about how to order equipment or arrange other support - we usually pay the supplier of the equipment or service directly.

- Whenever you see this evidence icon <a>col</a> you must provide evidence to support your application. Information about the evidence required can be found in the evidence tables in the notes and will be marked with this evidence icon.
